The President's Message

Every year my brother and father go down to unit 35B to chase after coues deer in the mountains southeast of Patagonia, AZ. This year was no different and once again I tagged along for the sole purpose of predator hunting in an area I am not as familiar with. I get bored with the typical terrain around the valley and always enjoy getting back in some out of the way location to call in foxes, coyotes, bobcats, and if lucky, a mountain lion. Anyone who remembers my trip last year will recall I shot a lion but was unable to recover it. My plans this year were to intentionally go after lions. Hour long sets, lion vocalizations, and concentrating on long fingers that extended from the highest point of the mountain to the valley floor.

I had spent 2 days 1 month ago scouting the area and felt comfortable with the stands I had mapped out. We drove in Thursday and Friday I got up bright and early and set up on a good location with great visibility and began calling. 1 hour later I had called in a fox and a coyote but opted to not shoot. Second stand of the day was in the valley I had seen and shot the lion last year. After one hour of calling I packed up my gear and went back to camp for lunch having seen nothing on that stand.

That afternoon I had a local rancher call me on the phone. Someone had contacted him and let him know I was in the area. He asked if I could come to his ranch just North of Patagonia to see a lion kill on his property. I arrived and was lead to the back of his property where a foal of his had been killed and drug out here the night before by a lion. The lion has eaten on it and tried burying it under some leaves. The rancher asked if I would spend some time calling in this area and I agreed. For the next 5 hours I made 3 different stands in the area but saw nothing. The terrain was quite rough and the brush could have hidden just about anything.

At last light as I was having to strain to see I had a nicely furred-up coyote come running into the stand. He stood staring at my Whirling Woodpecker from about 30 feet. I lined up the cross hairs and dropped him with the rifle. The 22-250 left a sizable exit on the other side so I didn't skin him out but was surprised how nice the fur was. Night time temperatures were hovering around 35 degrees.

The next morning I returned and spend all morning watching the foal and no lion showed up. By noon I decided to move onto another location. At this point I was growing board of listening to lion whistles and non-aggressive growls and shortened my stands to 35-45 minutes and spent the last 5 minutes switching to gray fox distress. This enabled me to at least have a little action as gray foxes ALWAYS came running. I shot a few foxes to quell my frustration as for the remainder of the trip I never saw hide nor hair of a mountain lion.

It seems that when I am not intent on calling one in, they just show up and when I devote a specific hunt to finding one, they're nowhere to be found. I included a few pictures of the beautiful terrain I hunted in. Anyone going down to that area to hunt come and see me as I can steer you to some really great gray fox spots.

The novice hunt last month was a success with about a dozen people at the check-in. Two coyotes, three gray fox, one kit fox, and one bobcat were brought in by the teams. We are hoping for a larger turn out at this months hunt which will be on Saturday November 12th..
