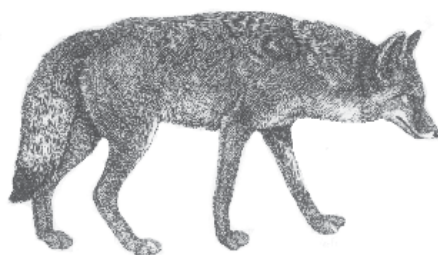

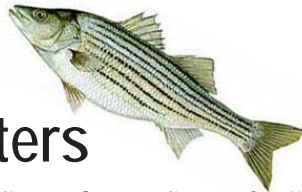

## Important information for hunters regarding road closures in southeastern Arizona

Sept. 30, 2014

Hunters and others engaging in outdoor recreation in southeastern Arizona are advised to be aware of (1) a road closure in Game Management Unit 32 in the Klondyke area, and (2) temporary storm-related closures of some roads and recreation sites in the Chiricahua Mountains (Game Management Unit 29).

### (1) Closure of **Long Hollow Road access point in GMU 32 — Klondyke area**

Due to a change in private land ownership in the area, there is no longer public access to State Trust lands or Forest Service lands through the Long Hollow Road access point (near Klondyke) in Game Management Unit 32.

### (2) Temporary road and recreation site closures in **Chiricahua Mountains (GMU 29)** due to storm damage

Due to damage from recent storms, the Coronado National Forest has temporarily closed some roads and recreation sites for public safety reasons in the Chiricahua Mountains in Game Management Unit 29. Below is a news release that was issued on Sept. 26 by the Coronado National Forest:

TUCSON, AZ (September 26, 2014) — Some roads and recreation sites located on the Douglas Ranger District of the Coronado National Forest are being temporarily closed due to damage related to recent storms in the area. The affected areas lie within the Chiricahua mountain range.

The following recreation sites are temporarily closed to human entry:

- Idlewilde Campground
- Stewart Campground
- Sunny Flat Campground
- John Hands Day Use Area
- Herb Martyr Day Use Area

National Forest System Road 42 from Pinery Administrative Site to Paradise is open to vehicular traffic. Motorists are advised to use caution and observe signs posted for safety purposes.

National Forest System Road 42 from the Cave Creek Visitor Center to the closure gate located approximately ½ mile northwest of the Southwestern Research Station, is closed to vehicular traffic, open to pedestrians and bicyclists.

The following are temporarily closed:

- National Forest System Roads 42A (Herb Martyr Road) and 42E (South Fork Road).
- National Forest System Roads 314 and 685.
- National Forest System Roads 74E, 628, 4243, 4244, 4245, 4246, 4248, and 7181.

Some areas will be gated, others posted with signs. Copies of the Special Closure Orders and maps will be posted at closed areas, available at the Douglas Ranger District Office, and posted on the Coronado National Forest [website](#).

The areas are closed to allow for public safety in the Chiricahua Mountains after recent flood events caused significant road damage and erosion concerns. Closures will remain in effect until September 22, 2015, or until rescinded, whichever event occurs first.

Reports indicate that saturated soils and runoff debris are present in many areas of the Chiricahua Mountains. Motorists, pedestrians and bicyclists are urged to use extreme caution while in the area, and are advised that even small amounts of precipitation may result in flash flooding.

Alternative recreation sites on the Douglas Ranger District are currently open.

Rustler Park Campground can be reached by National Forest System Road (NFSR) 42. At 8,500 feet in elevation, 22 campsites can accommodate tents or trailers up to 22 feet in length.

On the west side of the Chiricahuas, Sycamore Campground can be reached on NFSR 41. The campground sits at 6,200 feet in elevation, with eight camp sites which can accommodate tents or trailers up to 16 feet in length.

Also on the west side of the Chiricahuas, Camp Rucker Group Site can be accessed by NFSR 74. At 5,600 feet in elevation, 11 campsites are available that can accommodate tents and trailers up to 16 feet in length.

In the Dragoon Mountains, Cochise Stronghold can be accessed by NFSR 84. At 5,000 feet, 12 camp sites can accommodate trailers up to 22 feet in length.

Drinking water and electricity are not available at the sites.

## Arizona Game and Fish Changes Hunting Regulations for Night Hunting Coyotes

Arizona Game and Fish have changed the hunting regulations for hunting coyotes at night in the 2014-2015 Hunting Regulations. There are three changes and they are discussed below or click the Arizona hunting regulations link to see the changes.

- The length of the season has changed from a 3 month season to a 6 month season. Went from 3/1/14 thru 5/31/14 to now 12/1/14 thru 5/31/15. Personally I think the season should be open year long, however this is a step in the right direction.
- They changed it from a Limited Weapon-Shotgun Shooting Shot to a General season. Which means it is open to any means of legal take. In other words you can now use any legal firearm to take coyotes at night. This is the best change, as this will greatly increase your odds of being able to take a coyote at night.
- They added and removed some game units open to night hunting. They added some to northern and western Arizona and removed all units south of I10. Overall there was a gain of 2 units open to night hunting. Personally I think it should include all game units that are open in the General (daylight shooting hours) season.

Hopefully Arizona Game and Fish will keep improving the night hunting opportunities. Like make coyote night hunting season year long, open more units to night hunting and open some night hunting seasons for other predators.

# River Bull Elk Hunt

The week of September 15<sup>th</sup> was a little different than most of my weeks in that I was stuck in Tucson, in a hotel room because of a rare out-of-town job I had signed on for. This was the first September in quite a few years that I wasn't elk hunting somewhere. Hunting is always better than working, but the money was good so I was making the best of it; that is until Mother Nature decided to intervene. A hurricane off the coast of Mexico was making the weather pretty dicey in Southern Arizona so on Tuesday night we headed back to Mesa. About the time we hit Phoenix it started raining again. I wasn't sure what I was going to do with the forecast calling for several inches of rain in some areas.

I got up the next morning and decided that if I was going to have any chance at elk hunting I should sight in a couple of rifles just to be ready. I grabbed my Winchester 30-30 and my model 70 in 458 Lott. Both sporting open sights and no slings. I got a little break in the weather and both proved to be remarkably accurate with cast bullet loads. I knew the area I wanted to hunt was thick so the open sights were as good if not better than a scope.

I woke up to heavy rain about 4 am. By 8 am I was pumping water out of my backyard to keep the flood at bay. Seems that I checked the weather reports about every 10 minutes to see if I was going to be able to get out and do some hunting. About noon the rain had abated and I had pumped most of the water out of the back yard. I figured that if I was rained out of work, I might as well go elk hunting! I noted that the northern half of the state was not getting the rain. I called a buddy who told me to come on up and I headed north.

It wasn't raining when I left home but by the time I hit Payson it was coming down pretty steady. When I got to Heber I couldn't hardly see the road. I was worried that this was going to be a wasted trip! As I left Heber the rain broke and I could see a solid band of clouds behind me and mostly blue skies above and in front of me. I knew this was my day!

I arrived at his place about 4 pm and by 4:15 we were headed out. We glassed some thickets on our way to a little hole that we hoped might hold some elk but nothing was moving yet. I really wanted a raghorn bull that was not busted up. I have killed big bulls and spikes but never anything in between. I wanted a small rack that would fit on the wall and not take up too much space. We didn't see anything on the drive in and finally parked under a shade tree and headed off for what we thought was just a little evening jaunt to see if the elk were in the area. As I had both rifles with me I flipped a coin to see which would accompany me and the 458 won. My buddy couldn't believe the size of the hole in the barrel and was even more surprised when I showed him a loaded round. You certainly don't need an elephant rifle to hunt elk but the saying is that you can 'eat right up to the hole.'

We headed out along a fence line and found a corridor through the brush that took us deep into cover. We were hoping that the cool weather of the day would have the bulls talking. My tag said 'any elk' on it but I was really hoping for a small bull. We decided that if a big bull presented, Richard would take the shot. He only had a measly 30-06 with him but were pretty sure it might work!

We finally broke out into some open country and decided to cow call. I let out a couple of my most lovesick cow impressions and he did the same. We had not heard a single bugle and were a little worried that maybe the elk weren't here tonight. Not five minutes passed and I looked over to see a bull standing on the edge of the wash. He was a sneaky one and hadn't made a peep. I pulled up my binoculars and tapped Richard, pointed out the bull. The bull looked small enough and he immediately said "there's your bull." I guessed the range at about 175 and took careful aim. I was hoping not to shoot more than 100 yards but the front bead seemed steady enough on the big bodied bull. I had no choice but to shoot off my hind legs as we were in tamaracks up to our hips. I touched off a round and the big 458 bucked. We heard a loud thump and the bull was knocked to the ground! I had never seen an elk knocked off his feet like this and neither had Richard. It really flipped him over. I just that's what happens when you use caliber like this. We both turned and looked at each other and he gave me a high five. The bull started to crawl off the sand bar into the brush. I didn't get another shot but knew he was finished.



We headed down to the sand bar and realized that he was more like 200 yards from where we shot. I was now a little worried that maybe my shot wasn't as true as I had hoped. The wash was running but only about 6 inches deep. We walked across and took up the trail. The bull was a tough one and made it about 100 yards deep into brushy trees before we caught up with him. A quick shot through the heart and he was done. As I had feared, my first shot wasn't quite as good as it could have been. I finally got a chance to pull the antlers out of the under brush and look at him. I couldn't believe the points; six on one side and seven on the other yet a small, thin framed rack. This was a perfect bull; not a broken point and a bonus devil point.

We took some photos with our cell phones- all we had with us and then dressed him. The plan was to return later that night with a 4 wheeler and haul him out. We had no flashlights with us so we tried to hurry back to the wash so we could find the corridor we had walked in through before it was too late. In the hour we were messing with the bull the earlier rains had caught up with the wash. It was now waist deep and running bank to bank and rising! On top of that it was now dark! We used our phones to find a possible crossing and jumped in! Somehow we made it across without ending up downstream somewhere. This was supposed to be an easy hunt.

I had to wait until the next morning to recover the bull as I had no way to get across that swollen wash again and didn't know how to drive to the other side in the dark. Lucky for me, a friend was hunting in there on horse back the next day and I got him to loan me one of the horses. We loaded the meat on and packed it out to my truck. I was back home in less than 24 hours after I left!

Sometimes things just work out right. I can't wait to be rained out of work again! I might get to shoot an elephant someday but for now, I have the satisfaction that the 458 works just fine on elk!
